BYLAW NO. 1030, 2022

A Bylaw to Establish a Bylaw Notice Enforcement System

WHEREAS by sections 260(1) and 260(2)(b.1) of the *Community Charter*, SBC 2003, c 26, municipalities may enforce a bylaw by bylaw notice and establish a system for so doing in accordance with the *Local Government Bylaw Notice Enforcement Act*, SBC 2003, c. 60.

AND WHEREAS by section 1 of the *Local Government Bylaw Notice Enforcement Act*, a local government may designate as a "Bylaw Enforcement Officer" any person belonging to a class prescribed under section 273(c) of the *Community Charter*.

AND WHEREAS the Council deems it expedient to authorize the use of a Bylaw Notice Enforcement system for the enforcement of certain bylaws, to authorize the use of certain words or expressions to designate certain bylaw offences, and to set certain fine amounts.

NOW THEREFORE, Council for the Corporation of the Village of Burns Lake, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. CITATION

This Bylaw may be cited for all purposes as the "Corporation of the Village of Burns Lake Bylaw Notice Enforcement Bylaw No. 1030, 2022"

2. DEFINITIONS

"Act" means the *Local Government Bylaw Notice of Enforcement Act*, S.B.C. 2003, c 60.

"Adjudication" means the formal decision or judgement given by an administrative authority in resolution of a dispute.

"Bylaw Contravention" means an offence defined under section 5 of this Bylaw that may be enforced under this Bylaw.

"Bylaw Enforcement Officer" or "Bylaw Officer" means a person designated as such under this bylaw.

"Bylaw Notice" means a Bylaw Notice under section 4 of the Act and under this Bylaw, in the form of a written notice or ticket, giving notification of a contravention of a bylaw identified in Schedule 1;

"Disputant" means a person against whom a bylaw notice has been issued, and who has filed a notice of dispute or otherwise requested an adjudication of that bylaw notice.

"Municipality" means the Corporation of the Village of Burns Lake;

“Registry” means the Bylaw Dispute Adjudication Registry established or adopted under section 8 of this Bylaw;

“Regulation” means the *Bylaw Notice Enforcement Regulation*, BC Reg. 175/2004 under the Act;

“Screening Officer” means a person appointed to that position under this bylaw.

3. DESIGNATION OF BYLAWS TO BE ENFORCED BY BYLAW NOTICE

- (a) The bylaws listed in the “Designated Bylaws” column of Schedule 1 to this bylaw may be enforced by means of a bylaw notice.
- (b) A designated bylaw is not required to have a provision within the bylaw that specifies that the bylaw may be enforced by bylaw notice.

4. DESIGNATION OF BYLAW ENFORCEMENT OFFICERS

The persons appointed to the job positions or titles listed in the “Designated Bylaw Enforcement Officers” column of Schedule 1 to this bylaw are designated as “Bylaw Enforcement Officers” pursuant to section 1 of the Act for the purpose of enforcing the bylaws listed in Schedule 1 opposite the respective job positions.

5. DESIGNATION OF BYLAW CONTRAVENTIONS

- (a) The bylaw section numbers and descriptions in the “Section” and “Description” columns of Schedules 2-10 to this bylaw designate the bylaw contraventions that constitute an offence that may be enforced by means of a bylaw notice.
- (b) Each day that a bylaw contravention exists shall be deemed to be a separate and distinct offence that may be enforced by means of a bylaw notice.
- (c) Where a bylaw contravention is a continuous one, each day that the offence is continued shall constitute a separate offence that may be enforced by means of a bylaw notice.

6. DESIGNATION OF PENALTIES

The amount of penalty for a bylaw contravention designated in Section 5 is:

- (a) Subject to Subsection (b), the amount set out in the “Penalty” column of Schedules 2-10 to this bylaw that is opposite the respective bylaw contravention designated in Section 5.
- (b) Any penalty under section 6(a) of this Bylaw:
 - i. will be discounted by 25% as set out in the “Early Payment Penalty” column of Schedules 2-10, if that discounted amount is paid in full within 7 calendar days of the bylaw notice being served in accordance with the Act; and

- ii. will be increased by 25%, or to \$500 if the 25% increase would otherwise cause the penalty to exceed \$500, as set out in the “Late Payment Penalty” column of Schedules 2-10, if the full amount of the penalty is not paid within 14 calendar days.

7. PERIOD FOR PAYING OR DISPUTING

- (a) A person who receives a bylaw notice must, within 14 calendar days:
 - i. pay the penalty associated with the bylaw notice in accordance with that bylaw notice; or
 - ii. request an adjudication of that bylaw notice in accordance with the instructions on that bylaw notice.
- (b) Where a person does not receive notice of a bylaw notice and notifies the Municipality in accordance with section 25 of the Act, the time periods imposed by sections 6(b) and 7(a) of this bylaw do not begin to run until a copy of the bylaw notice is re-delivered to the person in accordance with the Act.

8. ADJUDICATION REGISTRY

- (a) In accordance with the Act, the Municipality establishes an adjudication system and Registry, for the purpose of resolving disputes concerning bylaw notices.
- (b) The address of the Registry is 15 3rd Ave, P.O. Box 570, Burns Lake, BC, V0J 1E0, or any other address which may be designated by schedule to this bylaw.
- (c) The Registry may set its own rules of procedure in respect of the receipt and processing of bylaw notice disputes, provided those rules do not conflict with the Act.
- (d) A person who disputes a bylaw notice and does not succeed in that dispute must pay the Municipality \$25 to recover part of the costs of administering the Registry.
- (e) The Municipality is authorized to enter into, and the Corporate Officer is authorized to execute, any Bylaw Dispute Adjudication Registry Agreement in accordance with the authority of section 2(4) of the Act.
- (f) Once any Bylaw Dispute Adjudication Agreement, is adopted by the Municipality and entered into with the provider of that Bylaw Dispute Adjudication Registry, that Dispute Adjudication Registry becomes the Registry for the purposes of this Bylaw.

9. SCREENING OFFICER

- (a) The position of Screening Officer is hereby established.
- (b) The following positions are designated as a Screening Officer:
 - i. Director of Protective Service
 - ii. Director of Public Works

- (c) Officers and Employees of the Municipality may be appointed as screening officers and Council may appoint screening officers by name of office or otherwise.

10. POWERS, DUTIES, FUNCTIONS OF SCREENING OFFICERS

The powers, obligations, duties, and functions of Screening Officers include but are not limited to the powers, obligations, duties, and functions under the Act, and also include the following:

- (a) No person may act as a Screening Officer in respect of a bylaw notice if that person:
 - i. has issued or signed the bylaw notice;
 - ii. is a complainant in respect of the bylaw notice;
 - iii. is or is reasonably likely to become a witness in respect of that bylaw notice;
 - iv. has provided evidence, including documentary evidence, in respect of that bylaw notice.
- (b) When requested by the person against whom a contravention is alleged, the Screening Officer must communicate to that person, or that person's agent, sufficient information regarding:
 - i. the nature of the contravention;
 - ii. the section of the bylaw contravened;
 - iii. the facts underlying the allegation of the contravention;
 - iv. the penalty for a contravention, including the fees payable, and any potential increased or discounted fees based on early or late payment;
 - v. the opportunity and process to dispute the bylaw notice and proceed to the bylaw notice dispute adjudication system.
- (c) To perform the Screening Officer's powers, obligations, duties, and functions under this bylaw or the Act, a Screening Officer may communicate with:
 - i. the Disputant, Disputant's representative, or a director or officer of the Disputant if the Disputant is a corporation or organization;
 - ii. the person who issued the bylaw notice;
 - iii. the complainant or complainant's representative;
 - iv. any Municipality staff concerning the contravention alleged, or any other contravention associated with the Disputant.

- (d) A Screening Officer may cancel a bylaw notice in accordance with the Act, or in accordance with the process established by the Municipality.
- (e) A Screening Officer may not prepare and enter into a compliance agreement under the Act with a Disputant.

11. SCHEDULES

For the purposes of this bylaw, Schedules 1-10 are attached to and form part of this bylaw.

12. FORMS

The Municipality may prescribe forms for the bylaw notice, forms to request an adjudication, or other forms in furtherance of this bylaw, provided the form complies with the Act.

13. EFFECTIVE DATE

This bylaw shall take effect upon the date of its adoption.

14. SEVERABILITY


If any portion of this Bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion of the bylaw must be severed from the bylaw and the remainder of the bylaw is deemed to have been adopted without the severed portion.
